

## **Juris Logium Public Websites' Terms of Use**

Welcome to the websites of the law firm of Juris Logium. This Agreement covers your use of the publicly accessible website [www.jurislogium.com](http://www.jurislogium.com). By using the Juris Logium website, you agree to be bound by these terms of service. Some sections of this Agreement modify very important rights. In those sections, the text is written in all capital letters. As you review this Agreement, please pay particular attention to those sections in all capital letters.

### **1. This Agreement**

The following sections describe the basic parameters of the Agreement, including requirements for eligibility to use the Juris Logium website, modification of this agreement, termination of this agreement, and how Juris Logium gives notice of changes to this agreement. **This agreement was last modified on September 28, 2015**

#### **1.1. The Agreement**

This Terms of Use Agreement ("Agreement") sets forth the legally binding terms for your use of the IP Logium website. By using this website, you agree to be bound by this Agreement. You are only authorized to use the Juris Logium website, whether such use is intentional or not, if you agree to abide by this Agreement, and all other applicable laws. Please read this agreement carefully and save it. If you do not agree with it, you should leave the Juris Logium website immediately, and discontinue use of the Juris Logium websites.

#### **1.2. Modification of This Agreement**

Juris Logium may modify this Agreement from time to time and such modification will be effective upon posting on all of the Juris Logium website. You agree to be bound to any changes to this Agreement when you use a Juris Logium website or Juris Logium service after any such modification is posted. It is important that you review this Agreement regularly to ensure you are aware of any changes.

#### **1.3. Termination of This Agreement**

Juris Logium may terminate this Agreement without prior notice and at Juris Logium's sole discretion. Termination of this Agreement will result in revocation of the license granted in section 2 of this agreement, and denial of access to Juris Logium website. Cause for such termination may include, but is not limited to:

## **3. Your Obligations**

### **3.1. Client Conduct**

You agree that you will not use the Juris Logium website to:

- (a) transmit or make available any content that is unlawful, harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, libelous, invasive of another's privacy, hateful, or racially, ethnically or otherwise objectionable;
- (b) harm minors in any way;
- (c) impersonate any person or entity, including, but not limited to, or falsely state or otherwise misrepresent your affiliation with a person or entity;
- (d) transmit or make available any unsolicited or unauthorized advertising, promotional materials, "junk mail," "spam," "chain letters," "pyramid schemes," or any other form of solicitation, except in those areas (such as shopping) that are designated for such purpose;

### **8.2. Choice of Law, Forum, and Venue**

THE LAWS OF THE COUNTRY WITH COMPETENT COURTS OF JURISDICTIONS , WITHOUT GIVING EFFECT TO ITS CONFLICT OF LAWS PRINCIPLES, GOVERN ALL MATTERS ARISING OUT OF OR RELATED TO THIS AGREEMENT AND THE TRANSACTIONS IT CONTEMPLETES, INCLUDING, WITHOUT LIMITATION, ITS INTERPRETATION, CONSTRUCTION, PERFORMANCE, AND ENFORCEMENT.

You have agreed in Section 7 to submit to the court of competent jurisdiction.

### **8.3. Severability and Waiver**

Juris Logium's failure to exercise or enforce any right granted in this Agreement shall not constitute a waiver of such right. If any provision of this Agreement is found by a court of competent jurisdiction to be invalid, you nonetheless agree that such court should endeavor to give full effect to the parties' intentions as reflected in such provision, and you agree that other provisions of the Agreement remain in full effect.

### **8.4. No Agency**

This Agreement creates no agency, partnership, joint venture, employee-employer or franchiser-franchisee relationship between you and IP Logium, and intends no such relationship.

### **8.5. Survival**

Sections 6, 7, and 8 will survive the termination or expiration of this agreement.

### **8.6. Claim Time Limitation**

You agree that regardless of any law to the contrary, any claim or cause of action arising out of or related to use of the IP Logium website, or this Agreement must be filed within one year after such claim or cause of action arises or be forever barred.
